Development Planning and Reporting

- Design, implement and manage the annual development plan and timeline
- Create and regularly update a detailed annual development budget
- Report regularly to the President and Board on fundraising progress against goals, pipeline of prospects, and other pertinent developments
- Work with Compass' Director of Impact to more effectively use data to drive strategy

Direct Fundraising

Identify, cultivate, solicit and steward institutional funders and individual donors to grow • funding base for Greater Washington

- Manage relationships, and develop strategies, to support Compass' corporate partners to sustain and increase funding
- Provide fundraising strategy and guidance as needed for Compass Philadelphia and Compass Chicago (direct fundraising managed by staff in those markets)
- Work with Compass' volunteers to secure matching funds and volunteerism grants
- Lead the strategy for foundation grants, managing the calendar and overseeing grant writing and reporting, which may involve managing an external grant writer
- Manage Operations & Development Associate to ensure gift entry into Salesforce and gift acknowledgement process
- Work closely with the Communications Manager on Annual Report and other communications vehicles
- Spearhead occasional fundraising events, including anniversary celebrations
