FROM THE PRESIDENT

So Much More To Do

As I mark the end of my 13th year with Compass, I continue to get the question I've been asked over the years - why have I stayed at Compass this long. My answer has always been the same - I don't feel done yet. When I took the position in 2007, I knew Compass had tremendous potential to do more than it was doing. I was right. Since then we have added new programs to support nonprofits, like Micro Projects, On Board and the Sorkin Center at Compass. We have added two new cities, resulting in robust programs in Philadelphia and Chicago. Our 2007 one-person shop is now 14 strong across the three Compass cities. With all of this growth behind us, we were moving ahead with our Strategic Plan's carefully considered growth goals just last year. A few months later, everything changed.

When Covid-19 hit our communities, we jumped to action to support nonprofits with new On Demand projects and Compass Connect conversations for Executive Directors and board members. When racial equity protesters marched across the country, we created Compass Connect conversations for Executive Directors to talk to each other and to consider their role and responsibility at this moment. And we feel like we are just beginning.

What we know about the year ahead is that we don't know what will happen. I can't remember when I've felt so much uncertainty across the nonprofit sector. As uncertainty turns to reality, Compass will be here to respond to nonprofit needs as those needs change. While a challenging time, this will also be a defining moment for our sector, because there is so much at stake. Compass' commitment has never been stronger or as important.

Our communities need nonprofits more than ever. In return, Compass offers many opportunities for nonprofits themselves to receive support. Our **Classic Client Application** is open for consulting projects that will begin in September. We added a new consulting option this year called **Decision Support**, to support nonprofits adjusting as the year unfolds. **On Demand** projects, which last 2-6 weeks, are available for nonprofits that need help right now. We are also still matching **Thought Partners** with nonprofit Executive Directors. Finally, **Compass Connect** conversations continue to address issues around Covid-19, as well as racial equity and social justice. (Details on all of these opportunities below.)

Social Justice Series

Following last week's session on "Understanding Anti-Racism and Your Role," the Sorkin Center will be hosting three Compass Connect conversations focused on social justice. Topics will be educational and will involve presentations, exercises and small group work. Nonprofit board members will be invited along with Executive Directors. Children and Youth Leadership Cohort

The Sorkin Center is piloting a Leadership Cohort of Executive Directors from youth-serving organizations in Greater Washington, Greater Philadelphia and Chicago. This Cohort will enable Executive Directors with common interests to virtually convene, share ideas and best practices, work through challenges, and strengthen the youth community. The Cohort will be limited in number to keep the group to a comfortable size and will meet twice a month over the next six months. - Lowering the eligibility requirements and streamlining the application for Classic Projects to attract a broader range of nonprofits
- Updating volunteer and client programs to provide appropriate support for DEIJ considerations
- Continuing On Demand and Thought Partners programs this summer, without nonprofit budget or size requirements, to expand access
- Engaging more Project Leaders and team members of color to strengthen our teams with more diverse perspectives and experiences
- Adding key metrics to our performance and impact evaluation to better measure against our DEIJ goals
- Looking internally at our staff and boards in all cities

We will provide more updates as we move ahead.
