THE YEAR IN REVIEW

2014-15 saw Compass reach new heights. Our programs in Greater Washington and Greater Philadelphia brought more people than ever into the local nonprofit sectors. Our strategic consulting services remained focused on nonprofit essentials: strategy, governance, funding, and collaborations – with each project tailored to the needs of each individual nonprofit. Our volunteers worked closely with Executive Directors and Board Chairs to address nonprofits' most pressing challenges and opportunities. Once again, Compass volunteers engaged at a deep level with the nonprofits that impact the communities where they live.

Highlights of the year included:

Greater Washington

64 consulting projects

386 consulting volunteers

14 business professionals placed on 12 nonprofit boards

82% of volunteers donated to Compass

42% of volunteers report donating to their Compass client

Greater Philadelphia

9 consulting projects

73 consulting volunteers

81% of volunteers donated to Compass

50% of volunteers report donating to their Compass client



Our new On Board program in Greater Washington moved from pilot mode to sustainability. Not only are nonprofits eager to find qualified board members from the business community, individuals in the business community are eager to find a board that is a good fit for their interests and skills. Such high interest levels led to our decision to run our On Board program twice per year going forward.

Compass Philadelphia also gained momentum, growing from four pilot projects the previous year to nine projects in 2014-15, and gaining a part-time Executive Director. Positive responses from local nonprofits, businesses and partner schools drove program success and impact in our second year.

We continue to be grateful to all our supporters who contributed financially to Compass through individual donations, foundation grants, and corporate sponsorships. In addition, we feel incredibly fortunate that more than 450 individuals volunteered with nonprofits through Compass in 2014-15. Finally, the Boards of Directors in Greater Washington and Greater Philadelphia, as well as the Advisory Board in Greater Washington, are our biggest champions. 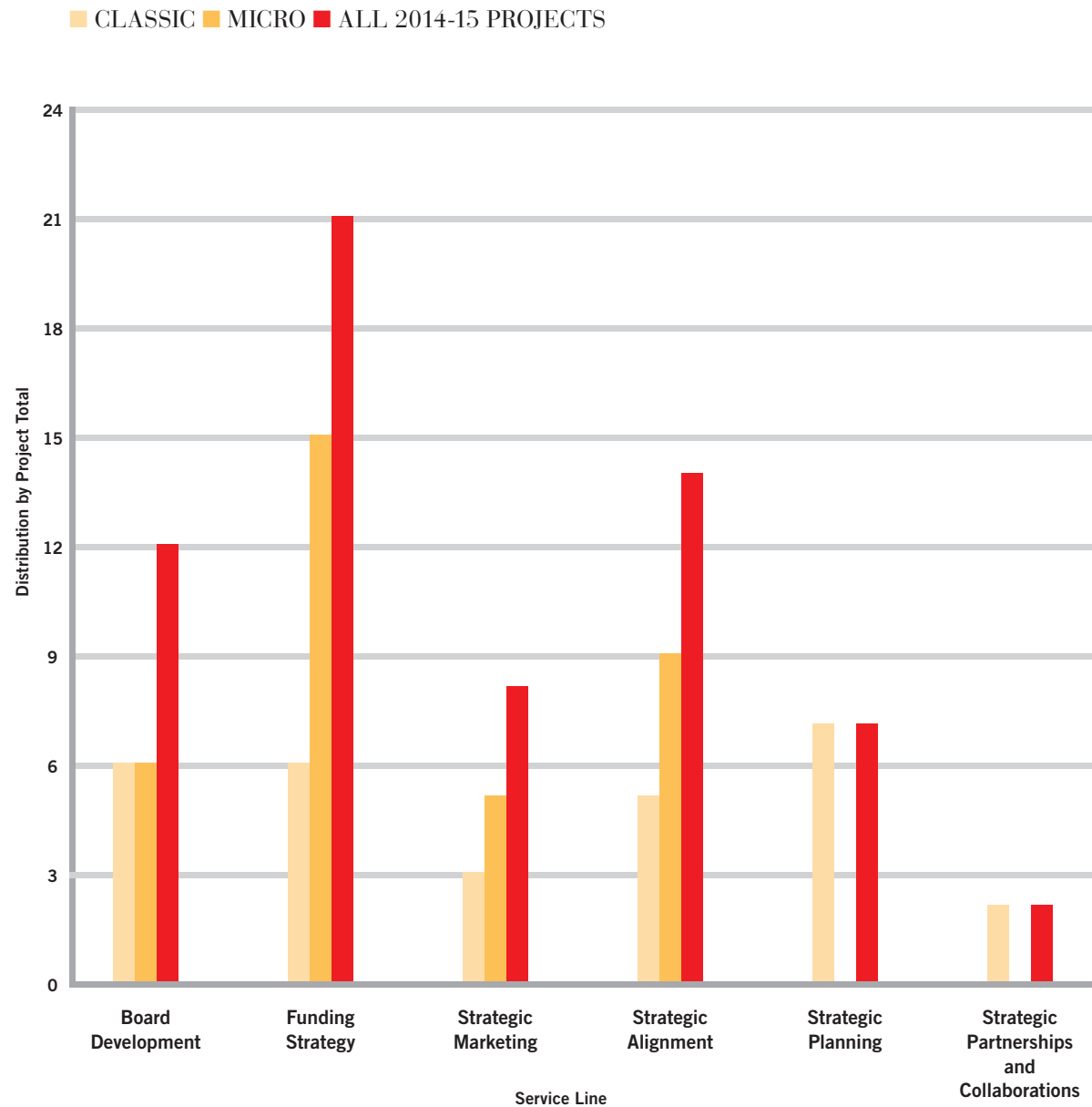

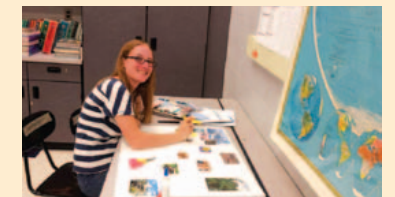

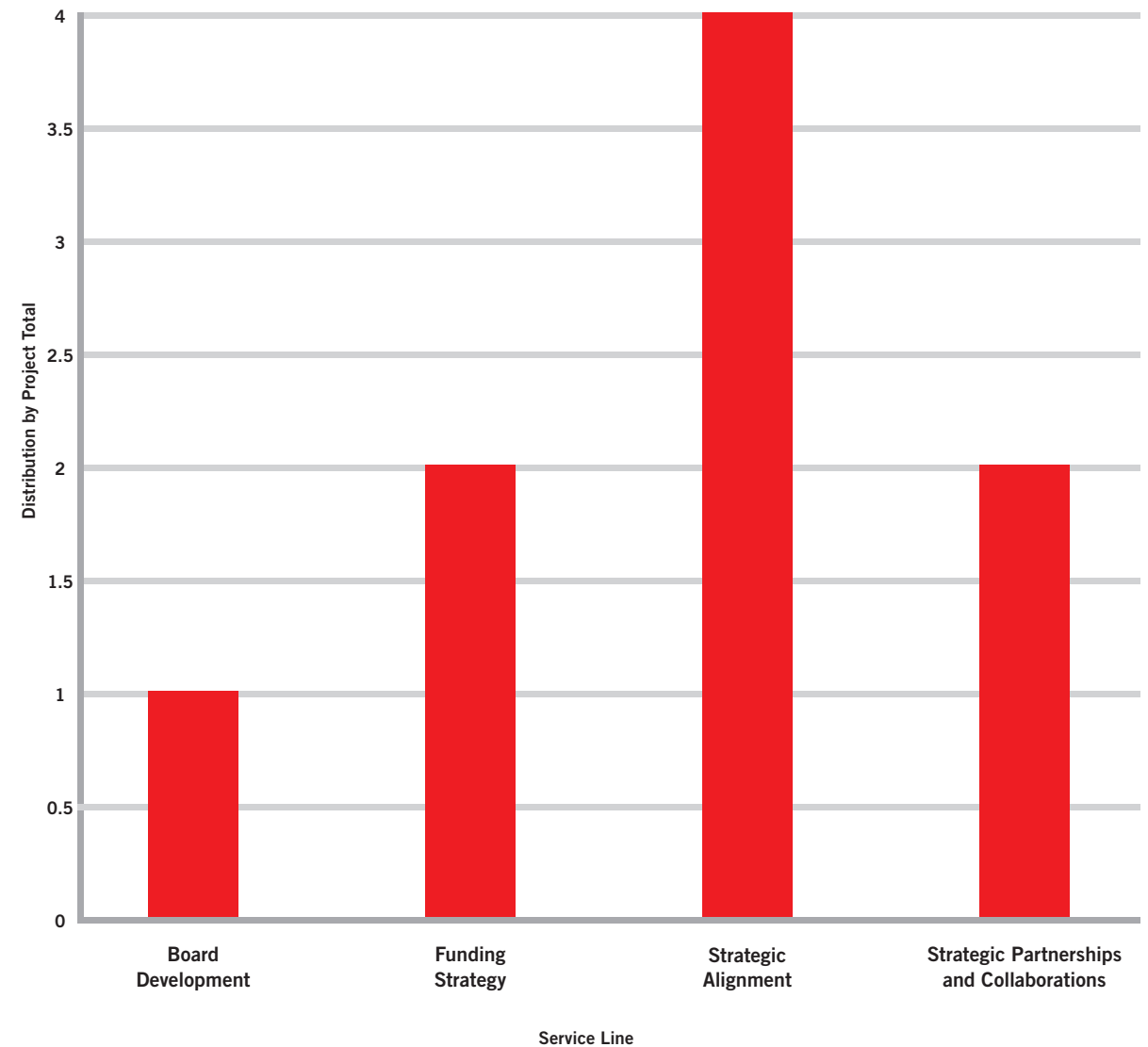

Pennsylvania Academy of the Fine Arts (PAFA)

I first learned about Compass through the Duke University Fuqua School of Business network. My Compass team was made up of professionals with experience in investment banking, public broadcasting, consulting, corporate law, and development work at an art museum. We organized several social gatherings to get to know one another and quickly became a close-knit group of friends and teammates. The junior consultants found mentors in the more seasoned MBAs on the team, a dynamic that only made our team stronger. The group had fun learning about two industries that were unfamiliar to most of us- art museums and art schools.

Our client, Pennsylvania Academy of the Fine Arts (PAFA), was founded in 1805 and is the nation's first school and museum of fine arts. PAFA wanted help with its enrollment, which had declined during the previous five years. My team interviewed more than 100 people including PAFA staff, current students, alumni, employees, the board of directors, and members of the arts and art school community. We took a more holistic approach and realized that there is no silver bullet to increase admissions. Instead, PAFA needs to improve its reputation by implementing a multi-approach strategy. The president and the board of directors were incredibly understanding of the project from the start. Their support made this project both successful and fun. Members of my team are continuing a dialogue with PAFA and its new dean of the art school to discuss the team's findings and how PAFA can continue to reach its goal of increasing student enrollment.

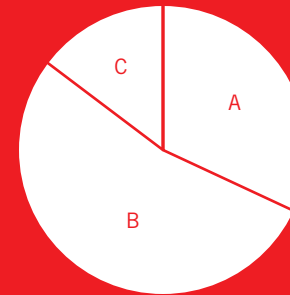

REVENUE AND EXPENSES

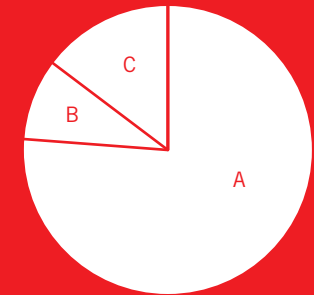
